

McKinney-Vento Homeless Assistance Act

New York's Education for Homeless Children and Youth program provides support to ensure that homeless children and youth have equal access to the same free, appropriate, public education - including public preschool - provided to other New York children, with the opportunity to meet the same challenging state content and student performance standards. Every school district, BOCES and charter school is required to have an LEA liaison whose duties include the removal of barriers to the enrollment, attendance and success of homeless children and youth in school.



The McKinney-Vento Homeless Assistance Act (42 U.S.C. § 11431 et seq., "McKinney-Vento") applies to students in a wide range of temporary living situations, including shelters and emergency or transitional housing; students living in hotels, motels, trailer parks, or camp grounds due to lack of alternative adequate housing; and also to students who are "doubled up" with friends or relatives due to loss of housing, economic hardship, or similar reason. Unaccompanied youth who live in these types of arrangements are also included under the protection of the law. Students who are protected by McKinney-Vento are entitled to immediate enrollment in their school of origin or their local school, and full participation in school.

Major Changes to McKinney-Vento Relating to New School District Responsibilities

The McKinney-Vento Act as reauthorized by ESSA has several important changes related to the following topics:


- 1. School of Origin Includes Preschool and Feeder Schools
- 2. School Selection Best Interest Determination
- 3. Children Awaiting Foster Care Placement
- 4. Enrollment Deadlines
- 5. Ensure Continued Enrollment Pending Final Resolution of Dispute
- 6. Award Full or Partial Credit for Completed Coursework
- 7. Ensure Access to Academic and Extra-Curricular Activities
- 8. Eliminate Barriers Related to Outstanding Fees, Fines, or Absences
- 9. Provide Transportation for the Remainder of the School Year
- 10. College Readiness
- 11. Student Privacy
- 12. McKinney-Vento Liaison Responsibilities
- 13. Affirm Eligibility for HUD Homeless Assistance
- 14. Coordinate Special Education Services
- 15. Collect Data
- 16. Improve the Identification of Children and Youth Experiencing Homelessness
